**Course Description:** Teaches students proper and safe usage of common automotive pullers, presses, Torch setup, basics of wire feed welding, and usage of plasma cutter. Provides preparation to take certification tests offered by the National Coalition of Certification Centers (NC3), and by the Fiat Chrysler Association (FCA).

**Course Objectives:** This course will be divided into these 3 core areas.

- 1. ShopKey Pro Level 2
- 2. Torque theory, Mechanical Torque and Electrical Torque
- 3. Fastener extraction, Puller/Press, Welding and Tube bending

No Required Textbook as all materials will be provided in Moodle or online.
